

**ROAD CLOSURE ORDER**

**TOWN POLICE CLAUSES ACT 1847**

**THE DISTRICT COUNCIL OF UTTLESFORD**

**TEMPORARY PROHIBITION OF TRAFFIC**

**(HATFIELD BROAD OAK 10K ROAD RACE) ORDER 2025**

WHEREAS application has been made to the District Council of Uttlesford for the temporary closure of the road described in the Schedule to this Order on the occasion of the Hatfield Broad Oak 10k Road Race to be held on Monday 26 May 2025 as the roads are liable to be thronged and obstructed;

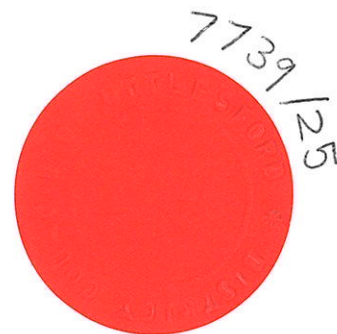
AND WHEREAS the said District Council is satisfied that the closure of the highways so described is necessary as the ordinary day to day use of the highways is likely to be dislocated by a substantial number of persons;

AND WHEREAS the Police and the County Council of Essex have raised no objection to the making of this Order provided that appropriate arrangements are made to exclude vehicles from the road affected by this Order and that suitable road closure notices are displayed;

NOW THEREFORE the District Council of Uttlesford in pursuance of the powers conferred by Section 21 of the Town Police Clauses Act 1847 and of all other enabling powers hereby makes the following Order:-

- 1 The roads or parts of roads described in the Schedule hereto shall be closed to vehicular traffic during the periods shown.
- 2 The Order may be cited as The District of Uttlesford Temporary Prohibition of Traffic (Hatfield Broad Oak 10k Road Race) Order 2024.
